FREE SCHOOL MEALS AND PUPIL PREMIUM

To enable us to provide students with the best education and support we need your information about you and your child / children to ensure that their school receives the government funding they are entitled to.

Families that receive certain benefits may be eligible for free school meals. Your child is eligible for free school meals if you are in receipt of one of the following benefits.

- Universal Credit with an annual net earned income of no more that £7,400.
- Income Support
- Income-based Jobseekers Allowance
- Income-related Employment and Support Allowance
- Support under Part 6 of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)
- Child Tax Credit (with no working Tax Credit) with an annual income of no more than £16,190.

Registering for free school meals could raise an extra £955 per year for your child's secondary school.

The additional money is available from central government for every child whose parent / carer is receiving one of the above benefits and would fund valuable support such as extra tuition, additional teaching staff or after school activities.

If you are not receiving one of the listed benefits and DO NOT wish to claim free school meals, it is not necessary to complete and return the form to the Academy.

To check if your child is eligible, you can either:

- Complete this form and return it the Academy by **Friday 4 December.** All details must be included.
